## Privacy Policy

The EAPCCT is committed to protecting the privacy of those who visit our website and utilize our services. The Privacy Policy governs how we collect, store, and use personal information about our website visitors. It will be continuously reexamined in light of a changing legal framework, new technologies, new business practices, and the changing needs of our visitors. This privacy policy applies to all personal data processed by the EAPCCT Board, volunteers when acting on behalf of the EAPCCT, contractors and partners doing business on behalf of the EAPCCT, as well as all legal entities and all business processes conducted by the EAPCCT.

### What Information Is Being Collected and How Will Your Information Be Used?

The EAPCCT does not collect any personal identifying information from users just browsing our website. Our server recognizes your domain name and the pages that you visit. These data are gathered in an aggregate manner for quality control, statistical purposes, and improvement of our site. This information is never forwarded to any third parties.

### Do We Employ Cookies?

The EAPCCT website uses no cookies.

### European Union Privacy Rights

Under the General Data Protection Regulation (also known as GDPR), if you are an individual protected by the GDPR, you have the following rights:

- **Access:** Members and users of the website may receive information about our processing of their personal data and a copy of their personal data.
- **Correct:** Members may request us to update or correct inaccurate data the EAPCCT has about them. They can also do this by accessing their information as described above.
